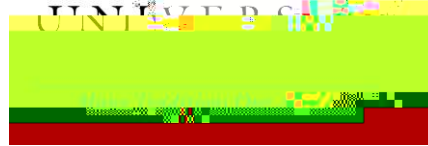

As you know, the Board of Regents passed the following motion at their September 12 meeting establishing review committees in key areas, working with the Chancellors, President Johnsen and I have identified you as the chair of one of these groups, Humanities and Social Sciences

To reduce costs and increase the share of resources dedicated to academic programs and student services, the Board of Regents directs the president, working with the chancellors form inter-university teams to conduct expedited program reviews of units and programs system wide, including but not limited to the following, to determine how best to integrate, reduce or discontinue units and programs:

The board further directs the president to work with academic review teams to determine which areas may require additional time past the November 2019 meeting and to provide those new target dates to the board in November along with recommended changes or findings, these reviews shall include typical information considered in routine program reviews to the extent available. This motion is effective September 12, 2019.

Each of the areas will be reviewed at a statewide level by an inter-university team comprised of faculty, administrators, staff, students, and community representatives. A review team will be convened by its chair, meet as needed, and provide a report to the President by 10/10/2019. The reports will be posted for governance and public input and you will give a brief update to the Board of Regents subcommittee tentatively scheduled for 10/16/19. The President and Chancellors will review the reports along with the governance and public input, and prepare options for consideration by the Board of Regents at its November 7 meeting.

This expedited program review will focus on broad structural issues associated with your unit. Your report address the following:

1. What degree programs would a single unit (college or school) serving the state include? *[I do not know what programs or areas your committee will look at so that I can ensure that we cover all of the major areas. If you want to break this committee into two working groups, let me know and I will solicit additional committee members.]*
2. Compared to our current structure of units or schools, what would be the administrative savings of moving from several units or schools to one?
3. Assuming a peer average full-time student:faculty ratio, what would be the instructional cost reduction compared to our current state?
4. What issues need to be resolved if the unit is assigned to one of our three separately accredited universities?
5. What issues need to be resolved if the unit is part of a single accredited statewide university?

In preparing your report, consider the impacts of the state funding reductions and enrollment declines that UA is currently facing, also any issues or specialized accreditation (where appropriate) that could arise by a change in overall university structure or accreditation.

For input to the process, your committee should consider previous academic program reviews or recommendations where appropriate. University Institutional Research offices and the UA Office of Data Strategy and Institutional Research will provide additional data as needed. Post it to a Google Drive. Gwen Gruenig will provide more information on the location of the data and work with you to assign a member of our systemwide IR team to assist you on getting the data you need.

To facilitate this process, you are responsible for administrative support. You will need to record all meetings using Zoom and provide links to us. Please contact Kelly James (kajames6@alaska.edu) for information on recording meetings and budget for travel and related expenses associated with your meetings. We are getting the final membership names from governance and Kelly will be sending you the membership list by tomorrow. As you review the list, if you do not see the name of someone who you think would be key in this discussion, please let me know. Please contact your committee regarding their membership, setting up meetings and how they will access information.
